In addition, part-time faculty are expected to participate in the assessment of their performance, including administrative and student evaluations. Part-time faculty may also have opportunities to participate in various campus and staff development activities and are encouraged to be involved in the larger College or District community. Part-time faculty may be eligible to receive additional pay for office hours, additional assignments, and professional development events.
- Teach beginning, intermediate, and advanced studio art courses in one or more of the following areas: Ceramics, Painting, Graphic Design, Furniture, Sculpture, and Drawing/Printmaking.
