Essential Duties & Responsibilities

- 1. Teach courses in the School of Continuing Educations Education for Older Adults and Adults with Disabilities department.
- 2. Participate in curriculum development, program advisory groups, learning outcome development and assessments, and participate in appropriate professional development activities.
- 3. Collaborate effectively with other faculty, staff, and administrators to plan, develop, and execute related programs.
- 4. Instruct and assist in the growth and success of a diverse population of students through careful preparation of course materials and effective teaching methods including Online courses, and informed critical feedback on assignments and discussions.
- 5. Maintain scheduled office and campus hours, and participate in department/division meetings and committees.
- 6. Late afternoon, evening and/or weekend assignments may be required as part of the regular contract.
- 7. Lecture hours of teaching will range from 1 to 19 hours per week.

California Community College credential, "Valid for Life" (no longer issued), authorizing service as an instructor in the appropriate discipline; refer to Ed Code 87355 (If meeting qualifications with this credential, a copy of the valid lifetime credential must be submitted with the application.);
