## **DUTIES AND RESPONSIBILITIES**

1. Teach existing courses across the SJCC programs that prepare students for licensure by Board of Barbering & Cosmetology, including primarily the licensure as Cosmetologist as well as crossover programs for Hairstylist and Esthetician.

2. Lead creation and establishment of new curriculum and programs preparing student for licensure as Barber.

3. Technical Instruction and Practical Training in Shaving.

4. The subject of Preparation and Performance shall include, but is not limited to the following techniques and procedures: Preparing the client's hair for shaving, assessing the condition of the client's skin, performing shaving techniques, applying after-shave antiseptic following facial services, massaging the client's face, rolling cream massages.

5. Teach courses in assigned discipline by communicating subject matter clearly and effectively.

6. Adapt methodologies for students with special needs and different learning styles.

7. Demonstrate commitment to professional development, including but not limited to activities such as: participation in professional conferences, workshops, seminars, membership in professional organizations, research projects, publishing academic work, participation in statewide committees or organizations, etc.

8. Demonstrate sensitivity in working with students and staff of diverse racial, ethnic, academic and socio economic backgrounds, sexual orientation, and disabilities by showing respect for differences and the dignity of others.
