This is a part-time position as an Associate Instructor in the School of Continuing Education at West Valley College. The Facilities Maintenance Technician Certificate prepares students with a general overview of core-competencies identified by industry leaders for entry level positions as a Facility Maintenance Technician and Energy Efficiency Auditor or careers in sustainability jobs. Courses include Facilities Maintenance Job Readiness where student learn environmental awareness, communication skills, basic arithmetic calculations, computer skills, safety training, work order management systems, and troubleshooting & problem solving skills related to being a Facilities Maintenance Technician. Other courses include energy auditing and analytics and prepare students to understand fundamental components in conducting an energy efficiency audit, how to recognize, identify, and report on energy cost measure (ECM) opportunities, and indoor air quality considerations and impacts.

Salary and Benefits:

Salary is based on a percentage of workload, up to a maximum of 67% of a full-time load. Salary is prorated based on an initial hiring salary range of \$27,790-\$39,006 per semester; and is based on academic achievement, teaching and related experience.

- * Provide each student with a written course syllabus at the beginning of the course, as per instructions in the Faculty Handbook.
- * Refer students to appropriate college sources for information on counseling and other student services.
- * Assist students by providing advice on requirements for successful achievement in the members area of expertise.
- * Work cooperatively within the college community.
- * Foster an environment that protects academic freedom within the college community.
- * Foster a positive working environment that is free from harassment, prejudice and/or bias.
- * Demonstrate a respect for the dignity of each individual.
