This is an in-person instructional position. We seek applicants with a high degree of professionalism, a strong commitment to our students, diversity, and global awareness, and the ability to motivate and educate in an engaging manner. The college strives for faculty who are content experts and who are knowledgeable about best practices, innovative strategies, and instructional technologies that support teaching and learning.
