This is an in-person instructional position. The college strives for faculty who are content experts and who are knowledgeable about best practices, innovative strategies, and instructional technologies that support teaching and learning.

We seek applications for an adjunct (part-time) teaching position for a hybrid (blended) section of Geology 101, Introduction to Physical Geology, in the fall quarter, September 17 - December 11, 2025, and Geology 201, Earth History, in a subsequent quarter.
