- Provide academic and curriculum support to a diverse student and staff population. Serve as a
 resource regarding associate degree and certificate programs. Provide workshops on
 Apprenticeship related topics. Participate in college and division assignments and other
 departmental responsibilities. Develop liaisons and networks with on and off campus programs and
 agencies. Performs other duties as assigned.
