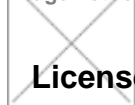

- Providing instruction in theory classes, skills lab, and or hospital/clinical laboratory experiences;
- Ensuring valuable clinical experiences for all students by taking leadership and team member responsibility in designated clinical settings;

or have completed a minimum of one-year full-time teaching experience in a state approved registered nursing or vocational or practical nursing, or psychiatric technician school within the last five years; or met community college or state university teaching requirements in California; **and**

3. Have a minimum of two years' experience as a registered nurse or licensed vocational nurse within the last five years.

Or

- (B) Licensed Vocational Nurse:
 1. Hold a current California active license as a Vocational Nurse; **and**
 2. Hold a baccalaureate degree from an approved school; or a valid teaching credential; or have completed a minimum of one-year full-time teaching experience in a state approved registered nursing or vocational or practical nursing, or psychiatric technician school within the last five years; or met community college or state university teaching requirements in California; **and**
 3. Have a minimum of two years' experience as a vocational nurse within the last five years.

(Note:A valid California Community College Credential will be accepted, however, applicants who possess this credential must also meet the above requirements.)

Desirable Qualifications:

- Experience and skill incorporating elements of diversity, equity, and inclusion into all areas of responsibility;
- Recent experience working with African American, Asian/Pacific Islander, Latinx, Native American, and other racially minoritized students in the classroom and an understanding of how historical patterns of exclusion of these groups in higher education shape patterns of participation and outcomes;
- Experience working with students of various cultural, gender, age, socioeconomic, and ethnic backgrounds including students with disabilities;
- Willingness to examine and remediate one's instructional, relational, and classroom practices to more effectively engage and support racially minoritized students;
- Experience in general nursing with a minimum of five years relevant clinical experience and two recent years of acute care experience in the clinical area of instruction;
- Education and/or experience in providing quality instruction in theory and clinical settings;
- Possession of a national certification in their area(s) of clinical expertise preferred;
