Serve as a resource person/Mentor for students needing to complete a Focused Remediation plan by 1) deciphering ATI test results; 2) assisting students to access individualized Focused Remediation plans on the ATI online site; 3) clarifying/reviewing the Nursing Program Student Manual (NPSM) guidelines; and 4) serve as a Mentor as students' progress in completion of their self-driven Focused Remediation plans. 7. Coordinate and Schedule repeat ATI testing of students with the assistance of the Course Lab Instructor and Course Facilitator. 8. Monitor student success on ATI repeat exams and communicate queried results to the Course Lab Instructor and Course Facilitator. 9. Provide end of semester ATI test result queries to the Course Facilitator/Department Head. 10.
