- (b) A bachelor's degree in education, English, linguistics, applied linguistics, any foreign language, composition, bilingual/bicultural studies, reading or speech; **AND** a certificate in teaching English as a second language, which may be completed concurrently during the first year of employment as a noncredit instructor. **OR**
- (c) A bachelor's degree with any of the majors specified in subparagraph (b) above; **AND** one year of experience teaching ESL in an accredited institution; **AND** a certificate in teaching English as a second language, which may be completed concurrently during the first year of employment as a noncredit instructor. **OR**
- (d) Possession of a full-time, clear California Designated Subjects Adult Education Teaching Credential authorizing instruction in ESL. **OR**
- (e) A combination of education and experience that is at least the equivalent of (a) or (b) above. Applicants submitting an application on the basis of equivalency must thoroughly and completely answer all of the equivalency questions, in addition to providing all other required materials.
- 2. Commitment to equity and diversity.
