*EQUIVALENCIES:

Equivalency of experience and significant professional achievement in lieu of the Baccalaureate (128 semester credit hours) or additional semester credit hours.

- 1. <u>APPLICABLE WORK EXPERIENCE</u>: Each year of full-time experience related to the Academic Discipline is equivalent to five (5) semester credit hours.
- 2. **APPLICABLE NON-COLLEGE TEACHING**: Each year of full-time experience is equivalent to five (5) semester credit hours.
- 3. <u>APPLICABLE COLLEGE TEACHING</u>: Each year of full-time experience is equivalent to six (6) semester credit hours. Every five (5) part-time contact hours is equivalent to one (1) semester credit hour.
- 4. **JOURNEYMAN CERTIFICATION**: The typical journeyman certification eligibility program requires four (4) years of full-time, progressive on-the-job training plus four (4) years of concurrent formal scholastic training at the rate of 36 weeks per year with four (4) hours of class work per week and six (6) hours of outside preparation per week. Each year of required full-time preparation (2000 on-thejob plus 360 total related) is equivalent to 13 semester credit hours, and each year of subsequent fulltime practice is equivalent to five (5) semester credit hours.
- 5. **PROFESSIONAL LICENSURE**: The typical professional licensure eligibility program requires two (2) years of formal scholastic training at the rate of 30 weeks per year with 18 or 22 hours of class work per week and 26 to 30 hours of outside preparation per week, or 1440 hours of professionally supervised laboratory and/or clinical work experience. Each year of required full-time preparation (1440 hours total) is equivalent to 32 semester credit hours, and each year of subsequent full-time practice is
